With Thinner ST 825 or Turpentine.

## Storage

The minimum shelf life in the unopened original container is one year; Storage temperature +5 - +30 ° C. Carefully close containers already opened! Store in a cool but frost-free place.

After expiry of the BBD, the product may still be processable, but the product properties may differ from "fresh" material. For that reason, the user must apply expired material with particular attention.

Isocyanate hardeners are moisture-sensitive. Always store in tightly closed containers.

## Disposal

Only empty containers may be recycled. Dispose of material residues according to local regulations. The EC waste code applicable to such material is: 08 01 11
