## **Special notes**

Do not process and dry PU lacquers below 15° C.

PU lacquers can be applied within one working day without any intermediate sanding. After that period of time, intermediate sanding must be made just before further processing, in order to ensure proper adhesion.

PU hardeners are affected by moisture. Always store the hardener in tightly closed original batches.

When using PU hardeners, always follow the safety instructions on the label.

PU hardeners can be stored in the closed original container at a cool and dry place for a maximum of one year.

The lacquer base is not lightfast. Depending on the selected colour, slight changes in colour may occur in the course of time. The intensity of yellowing depends on the coat thickness and on the intensity of the ultraviolet radiation of the sunlight.
