Processing

Shake or stir well before use!

Carry out intermediate sanding and collect the resulting wood dust in a clean container. Mix the Joint Filler Solution with the wood flour from the last intermediate sanding in a ratio of 2:1 to 5:1 (depending on the type of wood). During processing, Joint Filler Solution FK can be added as thinner. Use a stainless steel spatula to evenly apply the prepared mixture onto the floor and to fill all the small cracks and joints. Apply the product evenly and do not leave any excess on the floor. If cracks and joints become visible during processing, the mixture can be applied again by means of a spatula.

After sufficient drying, sand with a disk sander and P 150 sanding disks. If necessary, the levelling procedure can be repeated or a primer coat with Unocryl One-Pack Parquet primer UC-PG can be applied.
